## **I 、 Applicants' Eligibility 申請者資格**

**1. International students are those who are NOT with Republic of China nationality (according to Article 2 of Nationality Act of R.O.C.) and those who do NOT meet the following conditions :**

外國學生係指不具中華民國國籍（依據中華民國國籍法第二條規定）且不具下列各情形者：

**(1) He/She possesses overseas Chinese student status or has ever applied / studied in R.O.C. as an overseas Chinese student.**

具有僑生身份，或曾以僑生身份在臺申請入學或就學者。

**(2) He/She has applied and obtained a high school diploma as an international student in R.O.C. and would like to pursue a further degree.**

曾以外國學生身分申請並取得高中學位，並希望繼續在臺申請就讀大學者。

**(3) He/She has been expelled by a university or college in R.O.C.**

曾被國內大專校院退學者。

**(4) He/She holds nationality of Hong Kong or Macau or People's Republic of China.**

具有香港或澳門或中華人民共和國國籍者。

**(5) He/She held R.O.C. nationality and renounced it for less than 6 years ( till the date on which the school begins ) .**

曾具有中華民國國籍，且至本校開學日止，經內政部放棄國籍許可未達 6 年者。

**Violation of rules mentioned above found and proved will have the application rescinded and enrolled status cancelled immediately.**

倘違反上述規定並經查證屬實者，本校將撤銷入學資格並開除學籍。

**2. International students with high school diplomas are eligible to apply for undergraduate studies at NTOU.**

外國學生具高中畢業資格者，可提出本校學士學位班之入學申請。

**3. International students with Bachelor's degree are eligible to apply for master's programs at NTOU.**

外國學生具學士學位者，可提出本校碩士學位班之入學申請。

**4. International students with Master's degree are eligible to apply for Ph.D. programs at NTOU.**

外國學生具碩士學位者，可提出本校博士學位班之入學申請。

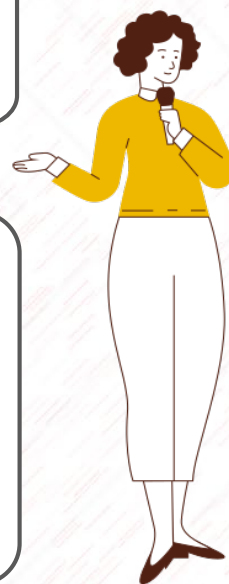

## IV、Application Notes 申請注意事項

1. Please make sure that after clicking 「Confirm and Submit」 in the application system, the system displays the page showing "Submitting Successfully" and "Your Application Number" (as shown in the image below), which indicates that the data has been successfully submitted. 請務必確認，於申請系統按下確認送出後，系統呈現出 Submitting Successfully 及申請件號碼的頁面(如下圖)，才代表資料已經成功送出。



2. Please note that submitting the information and documents does not mean the application is complete. The Office of International Affairs in NTOU will check all the materials and send another email to confirm whether your application has been successfully processed. If you do not receive the confirmation email within 7 days after submission, please promptly contact Mr. Sean Chang, the person in charge of foreign student admissions at NTOU OIA. 完成申請資料之提交不等同已完成申請，海大國際處將審核所提交之資料並另以信件通知申請完成與否，如未於7日內收到信件請立即聯繫海大國際處張正賢專員並提供申請件號碼。
3. If the information submitted by the applicant is incomplete, the applicant will be notified by letter to complete the submission within 7 days; otherwise, it will not be accepted after the deadline. 倘若申請者所提交之資料不完整，將另外以信件通知申請者於7日內完成補件，逾期將不受理。
4. Applicants who would like to apply for NTOU Scholarship must submit NTOU scholarship application form and certificates of extra-curricular activities (if any), when applying for admission. 欲申請本校外國學生獎學金之申請者，須於申請入學時將獎學金申請表及其他有助申請之文件一併提交。



5. **Applicants who would like to apply for NTOU must follow the "MOE Regulations Regarding International Students Undertaking Studies in Taiwan"** 申請至本校就讀之學生須依循「外國學生來台就學辦法之相關規定」辦理。
6. **Upon registration, new students must submit the original degree certificate and a proof of insurance which includes both medical and accidental, for a 6 months' period starting from the date of the arrival.** 註冊時，新生應檢附畢業證書正本及於入境日起算至少 6 個月效期之醫療與意外保險證明。
7. **NTOU International students should submit dormitory application form after agreeing to attend the fall semester no later than the early August (Fall Semester) and Mid-January (Spring Semester). If the form is not submitted on time, resulting in a loss of accommodation privileges, students will be responsible for finding their own accommodations.** 本校外國學生同意入學後最遲須於八月初(秋季班)與一月中(春季班)繳交住宿申請表。如逾期繳交或未繳致住宿權益受損，同學須自行負責。
8. **Students applying Bachelor Program from foreign countries, Hong Kong, and Macao whose graduating year is equivalent to the second grade of domestic senior high schools are required 12 more credits for graduation** 持國外或香港、澳門高級中等學校學歷，畢業年級相當於國內高級中等學校二年級之國外或香港、澳門同級同類學校畢業生，大學應加修 12 學分。
9. **Students who would like to defer Admission to a Later Term (Upmost 1 year) must submit an application of deferment. The scholarships are not guaranteed and student should apply again in new semester.** 學生若因故需延遲入學(至多一年)，需填寫延遲入學申請書。學生的獎學金資格將不被保留，並需於確定入學的同年度再次申請獎學金。
10. **Students must submit a copy of English degree certificate and transcript from graduated school that authenticated by the Overseas Missions. (The Overseas Missions means ROC embassies and consulates, representative offices, offices or other agencies authorized by the Ministry of Foreign Affairs in foreign countries)** 學生必須繳交經外館驗證之原畢業學校英文畢業證書與成績單影本一份

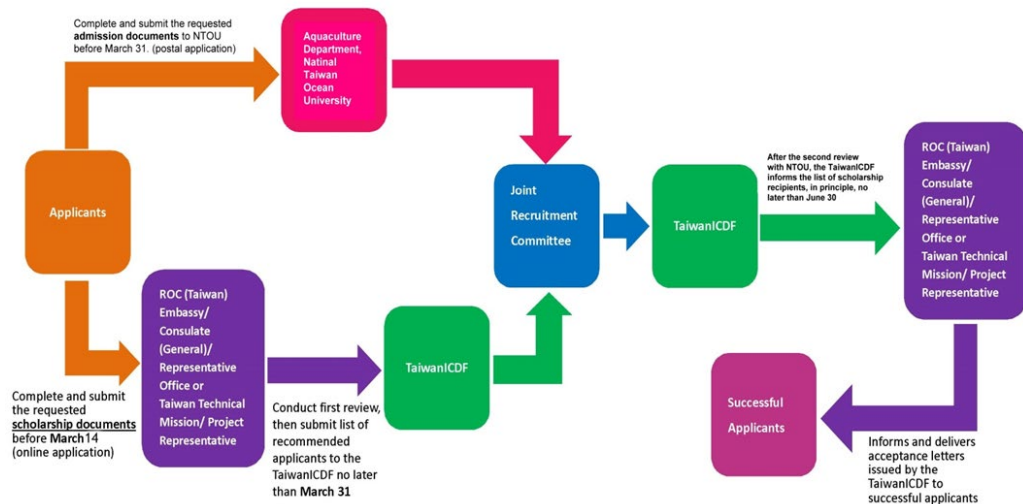

- (2) The Criteria of eligibility for NTOU Scholarship are as follows: Full-time current NTOU international students pursuing degrees must have average grades over 70 (for undergraduate students) and 80 (for graduate students) in previous semester. Applicants, who are not in receipt of any other scholarship or subsidy offered by Taiwan's or foreign government and other organizations, are eligible to apply. 受獎資格如下: 本校在籍外籍學士學位生前一學期平均成績超過 70 分；在籍外籍碩士學位生前一學期平均成績超過 80 分。所有外籍學生申請者(無論在籍或新生)不得同時受領我國或他國政府、機關、團體等補助獎學金者(如台灣獎學金、外交獎學金、太平洋獎學金、國合會獎學金等)。
- (3) The items of NTOU Scholarship include partial or full tuition fee and monthly allowance (Maximum NT\$12,000 =USD\$400.) Accommodation fee is not included. The duration of the Scholarship is one year and students have to apply every academic year. It is not guaranteed that the qualified students receive the same amounts of scholarship as the previous academic year. It is up to the academic performance the students achieved. NTOU 獎學金項目包含全額



或部分學雜費、學分費減免，及每月生活零用金（至多 NT \$12,000）；住宿費並非 NTOU 獎學金項目之一。獎學金期限為一學年，每學年均須提出申請，並會視學生學業表現調整獎學金額度。

- (4) **NTOU scholarship applicants, who used to receive a scholarship provided by Taiwanese government/institutions or by NTOU but were not able to complete the study during the designated term of the scholarship, can only apply for the monthly allowance for one academic year.** 申請者如曾獲我國政府機關團體之獎學金，但未能於獎學金核給期限內完成學業者，可申請每月生活零用金，並以一年為限。
- (5) **For Ph.D. students: Thesis Advisor often offers partial financial supports to students in addition to NTOU scholarships.** 博士學位學生:除了 NTOU 獎學金外,論文指導教授通常會提供部分財務支援給學生。

## 附錄：愛滋篩檢與治療費用通知書

(請健檢醫院將此通知書併同健康檢查證明發給受檢者)

- 一、臺灣政府已修改法令，取消非本國籍人類免疫缺乏病毒(HIV)感染者之入境、停留及居留限制，也取消此項健康檢查項目。
- 二、由於非本國籍人士在臺治療 HIV 感染之費用，臺灣政府不提供補助，每年治療費用約為新台幣三十萬元(約美金一萬元)，建議非本國籍人士於來臺前，先於母國接受 HIV 篩檢，了解自身健康狀況；如為 HIV 感染者，建議留在母國接受治療。欲來臺工作者，請先行購買醫療保險，以免造成個人財務負擔。
- 三、外籍人士來臺後，可自行至醫院進行 HIV 篩檢，了解自身感染狀況，在臺傳染病諮詢電話為 0800-001922。

## Phụ lục: Giấy thông báo chi phí xét nghiệm và điều trị HIV

(Đề nghị bệnh viện khi cấp Báo cáo khám sức khỏe thì cấp kèm Giấy thông báo này)

1. Chính phủ Đài Loan đã sửa đổi pháp lệnh, hủy bỏ quy định hạn chế nhập cảnh, tạm trú và cư trú đối với người nước ngoài bị Hội chứng suy giảm miễn dịch mắc phải (HIV), và cũng hủy bỏ hạng mục xét nghiệm này trong quy định khám sức khỏe.
2. Do Chính phủ Đài Loan không trợ cấp chi phí điều trị HIV tại Đài Loan cho người nước ngoài, mà chi phí điều trị mỗi năm khoảng 300 ngàn Đài tệ (khoảng 10 ngàn Đô la Mỹ), nên kiến nghị người nước ngoài, trước khi đến Đài Loan hãy tiến hành xét nghiệm HIV ở nước mình để nắm bắt tình hình sức khỏe của bản thân; nếu bị nhiễm HIV, kiến nghị hãy ở lại nước mình để điều trị. Đối với người dự định đến Đài Loan làm việc, kiến nghị hãy mua Bảo hiểm Sức khỏe trước, nhằm tránh gánh nặng tài chính cho bản thân.
3. Người nước ngoài sau khi đến Đài Loan có thể tự đến bệnh viện xét nghiệm HIV để nắm bắt tình hình nhiễm bệnh của mình, số điện thoại tư vấn bệnh truyền nhiễm tại địa bàn Đài Loan là: 0800-001922.

## **Appendix: Notice for HIV Screening and Treatment Costs**

**(Health examination hospitals shall issue this notice and health certificate to the examinee)**

- 1. The Government of Taiwan has revised its laws to lift restrictions on entry, stay and residence of non-Taiwanese nationals infected with human immunodeficiency virus (HIV) in addition to removing this item from health examination.**
- 2. The Government of Taiwan does not offer subsidies to non-Taiwanese nationals infected with HIV infection for treatment in Taiwan. The annual treatment costs for HIV is NTD\$300,000 (approximately USD\$10,000). It is strongly advised that non-Taiwanese nationals to undergo HIV screening in their homeland prior to visiting Taiwan in order to understand their own health conditions. Persons infected with HIV are strongly advised to stay in their homeland for treatment. Persons intending to work in Taiwan are advised to purchase medical health insurance in advance to avoid financial burdens.**
- 3. Upon entry into Taiwan, foreigners may undergo HIV screening at a hospital to determine their infection status. The consultation hotline for infectious diseases in Taiwan is 0800-001922.**

### **Lampiran : Surat Pemberitahuan Seleksi AIDS dan Biaya Pengobatan**

**(Mohon rumah sakit yang mengadakan pemeriksaan menyampaikan surat pemberitahuan ini beserta dengan surat keterangan pemeriksaan kesehatan kepada orang yang melakukan pemeriksaan)**

- 1. Pemerintah Taiwan telah mengubah peraturan , dimana telah membatalkan non warga negara Taiwan yang terjangkit virus (HIV) masuk ke negara ini , menetap dalam jangka waktu pendek atau menetap dalam jangka waktu yang lama yang dibatasi waktunya dan juga telah membatalkan item ini dari pemeriksaan kesehatan .**
- 2.
